

Subject: Report on vandalism, looting and burning of my  
Handloom machines at Bangla

Sir,

I have the honour to state that, as mentioned in the subject above, I would like to lodge F.I.R against the vandalism, looting and burning of my Handloom machines.

That, I was running one small industry in the name Christy Handloom which was set up at Bangla in between Kaprang village and S Kotlen village.

That, on the night of 3rd May 2023, some unknown persons had opened the said industry, vandalised and burnt all the materials in it. The average estimated cost value that they vandalised and burnt may be approximately Rs. 30,000/- (Rupees Seventy thousand) only per machine. The total Machine they burnt counts to 12 machines whose over all estimate reach to  $12 \times \text{Rs } 30,000/- = \text{Rs. } 3,60,000/-$  (Rupees Three lakhs Sixty thousand) only.

Therefore, I humbly beg you kindly to lodge F.I.R. in this matter regard with looking forward at your kind and earnestive implication.

For which act of your kindness, I will remain thankful to you.
