the undersigned beg to report for your kind and necessary action.

1. That, I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards. I WAS DWELLING AT NGATHAL, NEW LAMEKA, The ya
2. That, on 07/05/2023 at around 4:00 a.m./p.m., while I was at home along with my family members consisting of myself, my husband/wife, children and other family members, some unknown armed miscreants attacked my house physically assaulted my family members including myself and destroyed household properties worth around Rs. 2.45 Lakhs. (Rupees two Lakhs and forty five only) approximately. FROM MY HOTEL "NONG DAMBA" AT NGATHAL NEAR JUHI CLINIC.
3. That, the unknown miscreants are suspected to be of the Kuki tribe as they converse among themselves in the Kuki dialect while physically assaulting my family and destroying household properties. The said unknown armed miscreants also vandalised my house and further destroyed/damaged my household properties having total worth of Rs. /- (Rupees ) approximately (list of destroyed household items which are given in the list enclosed along with this report).
4. That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again. Delay of filing present report is due to displacement and residing in different relief camps.


