That, the unknown miscreants are suspected to be of the Kuki tribe as they converse among themselves in the Kuki dialect while physically assaulting my family and destroying m properties. The said unknown armed also vandalised my house and further destroyed/damaged my household properties havir approximately (list of destroyed household items which are given in the list enclosed alor with this report).

4. That, the unknown armed miscreants warned and threatened my family members an myself to leave the village permanently and that we will face dire consequences if we return to our village again. Delay of filing present report is due to displacement and residing different relief camps.

In view of the facts and circumstances, I shall be very grateful if your goodself would kind initiate appropriate steps for identifying the unknown arms miscreants, apprehend them as punish them in accordance with law.
