With due regards, I the undersigned namely Khwairakpam Ibocha Meitei, Age 79 yrs., a resident of Ngathal Meitei Leikai, on behalf of my son Khwairakpam Basn Meitei and my daughter Late Khwairakpam Mukta, a resident of Churachandpur Ngathal Meitei Leikai beg to submit the following few lines kind consideration and necessary action.

That on 03rd May 2023 at about 07:00 p.m. some unknown persons numbering about 100 to 300 Kuki and Zomi started attacking, destroying and burning the houses of my son and daughter, resulting in all the properties of the house were razed to the ground and all the belonging items were stolen before burning and damaging.

A separate sheet showing the particulars of all the losses incurred by me is attached along with the present application.

In the light of the above facts and circumstances, it is therefore respectfully requested that your goodself may cause the arrest of the miscreants who belong to the Kuki and Zomi community involved in the burning/dismantling/damaging of my family properties. So take up an FIR against them as soon as possible in the interest of Justice and urge to the concerned Authorities to compensate for those stolen, expired and damaged for all the properties belong to.
