Subject: Report on crimes of looting and vandalism

Sir/Madam,

With reference to the above cited subject, I have the honour to report to you as follows:
I, Jangkhohlam Haokip aged about 45 years H/o Lhinglemsem belongs to Kuki Community, a schedule Tribe Recognised under the constitution of India. Whereby, I am a permanent resident of T. Loklaiphai, T. Govindpur Cachar Mission Field. P.S. Churachandpur District.

On 5th May, 2023 at about 05:00 p.m. a group of Meitei/Meiteis miscreants attacked our Village. In the process they looted and vandalized all the properties.

That it is also worth mentioning that these criminal activities have caused agony and incurred a huge loss estimated at about Rs. 8,60,000 (Eight lakhs sixty thousand) only.

I was late in submitting this application as I was in different remote areas for months. Therefore I earnestly request you to kindly register a FIR and book the perpetrators under the appropriate section of law.
