

Subject :- Report on Looting household items/assets, and discrimination of Schedule Tribes.

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I **Zamkhogin** aged about 64 years S/o (L) **Zamkthothang** Belonging to the **Any-Kuki Tribe / Community**, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a permanent resident of **Kangvai Bazar, Churachandpur District Manipur P.O & P.S., Churachandpur**.
2. That at about 3 pm on the 3<sup>rd</sup> of May 2023, due to the ethnic violence, our village was attacked by a Meitei mob numbering about 1500 along with Arambai Tengol, and Police Commando. So in order to save our lives we left behind our house including all our household items and documents and took shelter at Assam Fifties Camp Kangvai. and in the process some unknown miscreants have looted our house including all our belongings which is located in the above mention address.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs.10,14,500 ( Rupees Ten Lakhs Fourteen Thousand Five Hundred) only**
4. Fortunately, I managed to escaped from the Violence, and now currently taking refuge at **Rostad School Relief Centre, D Phailen Village Churachandpur**
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at The above mentioned relief Centre. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an **FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
