Subject: Report on looting, Vandalism destruction of shop (Kutchra) house at Torbung bazaar.

Sir,

With reference to the above stated subject matter, a bare perusal of the facts may be stated herein;

That, I am the owner (Landlord) of a shop (Kutchra) house situated at **Torbung Bazaar**, Churachandpur, Manipur, wherein it was rented by one individual namely Mr. Seiminlen of Matejang Village, running a two wheeler repairing workshop.

And that, on the 3rd of May, the said house (Shop) was destroyed or burnt down by some unknown miscreant suspected to be from members -of Arambai Tenggol, Meetei Leepun and mobs comprising of Villagers from nearby Meetei village at about **8:00 PM** situated at the **above named location (Torbung Bazaar)**.

And, that there is no denying the fact that, there has been some delayed in reporting of the said incident due to negligence of the prevailing provisions of the rules and law pertaining to the registering of FIR and that, I was in state of shock and dilemma having suffered due to the constant attack by the said armed accused in the aftermath of 3rd of May, 2023.

It is hereby request of you to kindly look into the matter and registered the incident and book the culprit under any existing relevant provision of the law of the land.
