





Subject: Report on destruction and burning of my vehicle of Ford Make, Figo Model at Kangvai Bazaar.

Sir,

With reference to the above stated subject matter, a bare perusal of the facts may be stated herein;

That, on the 3rd of May, 2023 my **Ford Figo Bearing Regn No. MN02C 1045**, Chasis No. **1AJ1XXMRJ1DJ6675**, **Silver** Colour registered under the name of Mr. **Thangkhopao Haokip** S/o Hemkholun which was parked at the residence **Lavenna Vaiphei** situated near Mt Olive School, Kangvai Bazaar was burnt down at about **5:00 PM** by some unknown miscreants suspected to be from members of Arambai Tenggol, Metei Leepun etc.

And, that there has been some delayed in reporting of the said incident due to negligence of the prevailing provisions of the rules and law pertaining to the registering of FIR and that, I was in state of shock and dilemma having suffered due to the constant attack by the said armed accused in the aftermath of 3rd of May, 2023.

It, is hereby request of you to kindly look into the matter and registered the incident and book the culprit under any existing relevant provision of the law of the land.
