I would like to report that due to the ethnic violence which erupted on 03/05/2023 we have deserted our home located at Kangrai Village, ccfw. That on, 13/05/2023 at around 9:00 AM an information was received that my house was attacked, destroyed, vandalised and looted by unknown unruly Meitei mob numbering in thousands and all the valuable properties (as enclosed) were stolen away amounting to ₹ 3,42,700/- and while carrying out their criminal activities the said unknown Meitei unruly mob were shouting anti tribal slogans.

Due to shifting from one place to another, complaint could not be made on time.

Kindly take up necessary legal action against the persons involved at the earliest.
