Today ie 24/01/2024 received a reliable information that on the same day at around 9:15 AM security personnel conducting frisking and checking at Joint MVCP Check Post located at Torbung Bangla, Churachandpur have apprehended some individuals alongwith arms. Immediately, self alongwith escort party, W/ Insp Chinneilam Gangte, OC/ WPS-CCP alongwith escort party led by Shri Piangkhanmuan, MPS, ASP(L/O)CCP with escort party rushed to the spot. After necessary formalities, while returning back alongwith the deputed teams and the apprehended persons namely, James Haokip s/o Ngulkholet of Keithelmanbi Village, Kangpokpi District and Seiminlen DOUNGEL s/o Helthong of Tuibong, CCPur District and the seized items ie one Scorpio Turbo bearing Regd No: MN01K9493 and one 9mm Pistol alongwith one pistol magazine, the teams were waylaid and stopped by a group of women folks numbering around 200 at Kaprang Village, Churachandpur at around 3:45 PM, heated arguments and exchange of words followed. The teams were overpowered by the unknown women folks who forcefully snatched away the apprehended persons and the seized vehicle and hid away at an unknown location. But the teams some how managed to keep hold of the seized arms ie one 9mm Pistol alongwith one pistol magazine.

Hence a suo moto case under FIR No. 69(01)2024 CCP-PS u/s 143/149/506/224/225/186/34 IPC, 25(1-C) Arms Act is registered against the unknown women folks and James Haokip s/o Ngulkholet of Keithelmanbi Village, Kangpokpi District and Seiminlen DOUNGEL s/o Helthong of Tuibong, CCPur District for investigation.
