






I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident of  
Torbung, Churachandpur, Manipur

That, on the 3<sup>rd</sup> May, 2023 at 8:30 pm my above said residence "Owned/Rented" was  
attacked, destroyed, looted and burned by a group of Meitei/Meiteis radicals.

These criminals broke/open my gates, destroyed and looted every valuable property from my residence  
and premises worth Rs. 3400000 (Approx.) and they burnt down all the remaining.

While carrying out their said criminals activities, the said Meitei radical groups were shouting anti-tribals slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/Zero  
FIR under relevant sections of Law.
