Sir,

With due respect, I, the undersigned would like to lay the following few lines for your kind consideration and necessary action:

That, when the ethnic clashes between Meiteis and Kukis that broke out since the beginning of the 3rd May, 2023, due to fear and panic, I along with family members were compelled to abandon our house located at D Phailen Compound Veng, Churchandpur, Manipur, as it lies in a Kuki dominated area and taking shelter at the relief camp of Schedule Cast Girls Hostel, Leimaram. On 03/05/2023 at around 5:30 p.m. some unknown persons suspected to be kuki militants started to gut fire after valuable properties were stolen/looted away by the said unknown persons suspected to be kuki militants i.e. 1 semi pucca house worth Rs 10,00,000, 4 wooden bed (Worth Rs 80,000 @ Rs 20,000), 3 wooden almirah (Worth Rs 1,50,000 @ Rs 30,000), Iron godrej 2 (Worth Rs 30,000 @ Rs 15,000), 1 Sofa set (Worth Rs 40,000), 1 Flat Color TV (Worth Rs 20,000), 25 full bags of local paddy (worth Rs 40,000 @ Rs 1,600 per bag), 1 Maruty swift Car (Worth Rs 6,00,000). The approximate value of looted/stolen new properties is Rs. 19,60,000/- (Rupees nineteen lakhs and sixty thousand). I could not report well in time due to lack of legal knowledge and displacement.

It is therefore, requested you to kindly take up necessary against the unknown miscreants at the earliest.

AFFIDAVIT

I, Angom Geeta Devi, w/o A. Nongyai Singh of D Phailen Compound Veng, Churchandpur, P.O.O. & P.S. Churchandpur, Manipur at present Schedule Cast Girls Hostel relief camp, Leimaram. do here by take oath and solemnly affirm and declare as follows:

1. That, I am law abiding citizen of India by birth as such I am competent to swear this affidavit. This is true to the best of my knowledge.
2. That, I and my family members have been staying at the Schedule Cast Girls Hostel relief camp, Leimaram as victim of ongoing ethnic clash happening between Meitei and Kuki since 3rd May, 2023.
3. That, due to fear and panic, I along with family members were compelled to abandon our house located at D Phailen Compound Veng, Churchandpur, Manipur, as it lies in a Kuki dominated area and taking shelter at the relief camp of Schedule Cast Girls Hostel, Leimaram
4. That, On 03/05/2023 at around 5:30 p.m. some unknown persons suspected to be kuki militants started to gut fire after valuable properties were stolen/looted away by the said unknown persons suspected to be kuki militants.
5. That, items of damaged and stolen/looted properties are as follows : 1 semi pucca house worth Rs 10,00,000, 4 wooden bed (Worth Rs 80,000 @ Rs 20,000), 3 wooden almirah (Worth Rs 1,50,000 @ Rs 30,000), Iron godrej 2 (Worth Rs 30,000 @ Rs 15,000), 1 Sofa set (Worth Rs 40,000), 1 Flat Color TV (Worth Rs 20,000), 25 full bags of local paddy (worth Rs 40,000 @ Rs 1600 per bag), 1 Maruty swift Car (Worth Rs 6,00,000) The approximate value of looted/stolen new properties is Rs. 19,60,000/- (Rupees nineteen lakhs and sixty thousand).
6. That, I could not report to the nearby Police station about the looted/stolen properties in time due to lack of legal knowledge and displacement. Now I requested to take up necessary action against the unknown miscreants at the earliest.
