Respected Sir,

With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the Zou Tribe, which is a recognized tribe under the Constitution of India.

That, due to the prevailing ethnic crisis in the State of Manipur, on the 4<sup>th</sup> of May, 2023 at around 12:00 PM, a mob of unknown miscreants attacked our neighbouring Meetei/ Meitei houses/locality, in the process my rented house owned by Chingtungpau (6009014386), caught fire from the arson attacked on the neighbor's Meetei/ Meitei house, located at House No. C-4, Hiangzou Village, Zenhang Lamka, P.O., P.S. & district- Churachandpur, Manipur.

That, it may also be report that the said activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs.7,48,000/- (Rupees Seven Lakhs Forty-Eight Thousand) Only, inclusive of the household items/ movable properties and excluding the rented house, such as;
