Subject :- Report on Looting, Vandalism and burning down of Granaries, household items/assets.
And Discrimination of Schedule Tribe.

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I, Lamneihnieng aged about 60 years W/o (L) Paulunmang Vaiphei, Belonging to Vaiphei Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a permanent Resident of Kangvai Bazar Veng near SDO office, District Churachandpur, Manipur. P.O&P.S., Churachandpur.
2. That at about 3:30 pm on the 3rd of May 2023, a huge contingent of armed radical meitei/Meitei suspected to be members of the Arambai Tengol and Meitei Leepun along with Police Commando and a mob numbering about 2000 attacked our Village with sophisticated weapons. so in order to save our lives, I and my family have to run for their lives leaving behind our house along with all our household items and properties. And in the process they have looted then burnt down our Granaries (about 150 Bags) including some of our household items,
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs. 4,30,000/- (Rupees Four Lakhs Thirty Thousand) only.
4. Fortunately, we managed to escaped from the criminals who even tried to kill us, and now currently taking refuge at Salem Veng Churachandpur.
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at The above mentioned address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
