I, the undersigned have the honour to state that a large number of unidentified people belonging to the Kuki community including Kuki militant groups armed with deadly weapons and sophisticated arms stormed the Meitei inhabited areas of Thengra Leirak, Red Cross Road, Churachandpur, P.O & P.S- Churachandpur on 3rd day of May, 2023 at about 7:00 Pm. The said unidentified groups looted and burnt down our four storey building along with household materials. In such terrible acts of the said unidentified groups, I along with my family members ran away from Thengra Leirak, Red Cross Road, Churachandpur, to save our life and took shelter at 36 Assam Rifle, Churachandpur. Then my family left the 36 Assam Rifle on 9/5/2023. And started staying at the relief camp of Moirang College since 9/5/2023. Then my family took shelter at Kamakhya Pemton College, Hiyangthang since 19/6/2023. In that unfortunate incident I have lost my house and property amounting to a total amount of Rs:- 1.5 crore/- (one crore and fifty lakhs) approximately.

It is therefore, requested kindly initiate and take necessary legal actions against the accused persons involved in the said inhuman and barbarous act, as per law of the land as early as possible. I couldn't able to submit my complain report in time due to prevailing inconvenient situation.


