






Subject: Report on crimes of unlawful displacement, looting, vandalism and discrimination of Scheduled Tribes.

With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the *Vaiphei Tribe*, which is a recognized tribe under the Constitution of India and a permanent resident of Kangvai Bazar, Kangvai, P.O., P.S. & district- Churachandpur, Manipur.

That, due to the ethnic crisis in the State of Manipur, we deserted our above mentioned house on the 3rd of May, 2023 at around 3:30 PM, and during our absence, a mob of Meitei/ Meitei suspected to be members of Arambai Tengool and the locals in and around the area attacked our village, in the process they have looted and vandalized all the household items / movable assets, along with the installed assets of the house on the 4th of May, 2023 at around 6:30 PM.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about **Rs.15,00,000/- (Rupees Fifteen Lakhs)** Only, inclusive of my household items/ movable assets along with my house.

That, I am filing this report lately as I was with family at remote area.

Therefore, I humbly pray you to kindly register an FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application on behalf of my husband lately today.
