That, due to the ethnic crisis in the State of Manipur, we deserted our above mentioned house on the 3rd of May, 2023 at around 3:30 PM, and during our absence, a mob of Meetei/ Meitei suspected to be members of Arambai Tengool and the local in and around the area attacked our village, in the process they have looted and vandalized all the household items / movable assets on the 5th of May, 2023 at around 6:00 PM.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs.10,00,000/- (Rupees Ten Lakhs) Only, inclusive of my household items/ movable assets.

That, I am filing this report lately as I was with family at different places.

Therefore, I humbly pray you to kindly register an FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application on behalf of my husband lately today.
