

Subject: Request for registration of First Information Report

Sir,

I, the undersigned Mr. Khailian Thang Vaiphei S/o (L) Th. Lamkam Vaiphei aged about 61 years, Chief of Kangvai Village, Churachandpur District, Manipur-795004 would like to bring to your kind notice the occurrence of crime committed on my house as well as the destruction of other houses and properties in my Village (Kangvai)

The specifics of incident are as follows:

1. **Place of incident:** Residence of Mr. Khailian Thang Vaiphei S/o (L) Th. Lamkam Vaiphei at Kangvai Village, Churachandpur District/ Kangvai Village as a whole.
2. **Time of Incident:** 3rd May, 2023 at around 5pm

Brief history of the incident: On the day of May 3rd 2023 around 11 a.m, a Tribal Solidarity March was staged at Lamka, Churachandpur organized by ATSUM. The Meiteis being dissatisfied with the tribal solidarity March started a counter blockade at Torbung area located 800 meters South-West of Kangvai Village. The Meitei mob that was staging a protest at Torbung area suddenly turned violent and as a result violence broke out between the locals in the area. At around 5 p.m. Meitei mob gathered at Kangvai area and started pelting stones at the houses located alongside the main road. Since most of the villagers were at Lamka Peace Ground for the Tribal Solidarity March there was no one to defend the village. Taking advantage of the situation the Meitei mob started burning and destroying my house and properties and also went to the extent of burning many houses and properties belonging to individual villagers in my Village. The Meitei mob indiscriminately burnt down as many as 76 individual houses of the village all located in close proximity to the main road. Unfortunately, my house which I inherited from my late parents was also looted, burnt down and destroyed, along with all of my family heirlooms that had been passed down through generations. In all, out of 180 houses, 76 houses were burnt in the Village causing widespread damages & immense hardships to the villagers. All the affected families were one way or the other reallocated in relief camps.

This incident could not be reported earlier due to law and order situation as I was staying at Imphal when the violence broke out and considering the imminent threat for life I had to relocate my family to safety outside Manipur. Until recently, I had to take care of my ailing sister who was suffering from last-stage cancer. It took some time for me to recover from shocks my family went through such an awful ordeal and thus the delay to report on time.

Therefore, I earnestly request you to take appropriate stringent action against the perpetrators by registering an FIR under relevant sections of India Penal Code (IPC).
