I am a Schedule tribe belonging to the Vaiphei Tribe, which is a recognized tribe Under the Constitution of India and a permanent resident of Kangvai, ejuok veng CC-pur 795128, Kangvai, P.O., P.S. & district - Churachandpur, Manipur

That, due to ethnic crisis in the state of Manipur on 3rd May 2023, we left our house and during our absence, some unknown miscreants have looted and vandalized all the household items/ movable assets, along with the installed assets of the house on the 10th of May 2023 at around 6:30 P.m.

That, it may also report that said criminal activities have caused grave mental agony and incurred huge loss which is estimated to be about Rs. 6,00,000 (lakh) only, inclusive of my household items /movable assets along with my house

That, I am filing this report lately as I was with family at remote area.

Therefore, I humbly pray kindly register an FIR, and book the perpetrators under the Relevant Laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, filing this application on behalf of my husband lately today.
