On 15/2/2024 at around 7:30 pm, a large mob comprising about 1000 people converged in front of Mini Secretariat, Tuibong to protest against the suspension of Head constable Siamlalpaul whose video had gone viral on social media posing with some village volunteers without any authorisation at unknown location. The mob demanded immediate revocation of the suspension order. The mob stormed the gate of Mini Secretariat which was manned by Police, CAPF, Assam rifles personnel. The security forces have to resort to firing tear gas, stun shells, etc to disperse the unruly mob. After prolonged confrontation, the unruly mob managed to breach the northern gate (gate No.2) of Mini Secretariat and entered the campus. Another confrontation took place inside the campus in which the unruly mob was lathi charged and anti riot ammunitions fired upon. However, the unruly mob managed to burn down 12 vehicles parked inside Mini Secretariat campus and also set fire to DC/ CCpur building including DCs room, PA to DCs room, election department room and also vandalised the NIC rooms. The combined security forces resorted to use of non-lethal weapons for more than two hours to disperse the unruly mob but proved futile. Eventually, the combined security forces have to resort to firing live bullets in the air to disperse the unruly mob as a last option as some armed elements amongst the mob fired with guns towards the security personal. The mob was also seen bringing down the national flag hoisted at DC Office. Some security personnel as well as many persons from the unruly mob sustained injury during the confrontation. The unruly mob was finally dispersed from the Mini Secretariat campus at around 10:30 pm.

Hence, a Suo-moto case under FIR NO. 88(2)2024 CCP-PS u/s 143/147/148/149/188/324/353/427/435/436/34 IPC, 25(1-C) A. Act & 3/4 of PDPP Act, Sec. 2 of the Prevention of insults to National Honour Act, 1971 has been registered against the unruly mob for investigation.
