On 16/2/2024 at around 1:50 am received a reliable information that on the same day between 1:30 AM to 1:40 AM an assembly of unruly mob armed with deadly weapons numbering about 500/600 after burning down DC office located at Mini Secretariat Tuibong, Churachandpur proceed towards DC Bungalow at Headquarter Veng, Churachandpur and attacked, vandalised and burnt down the residential Quarter of the DC/ CCpur including all properties inside the Quarter, two vehicles i.e. Mahindra Scorpio and Hyundai Verna parked inside the garage and sentry post.

Hence, a Suo-moto case under FIR NO. 89(2)2024 CCP-PS 143/147/148/149/188/427/435/436/34 IPC, 3/4 of PDPP Act has been registered against the unruly mob for investigation.
