Today i.e. 16/02/2024 at 01:55 AM received a reliable information that on 15/02/2024 between 08:00 PM to 09:00 PM a large unruly mob numbering in hundreds have assembled infront of Old SP Office, Tuibong, Churachandpur in proptest against the suspension of HC Siandalpaul. The unruly mob turned violent and confrontation broke out between the mob and police personnel on duty. After prolong confrontation, the unruly mob managed to break the main gate thereby attacking, vandalising and burning down of office building and properties inside the building. The vandalized and burnt down buildings, properties and articles as follows: (1) Canteen + Escort Rest Room (2) Old SP Room (3) AHTU Room (4) Old Reader Room (5) 8 numbers of eletric wire 2.5 mm from store room (6) 25 numbers of LED bulb from store room (7) 8 numbers of flood light from store room (8) Computer printer of SGT-PS at CCTNS Room (9) Air conditioner at SP room office (10) Doors and windows of CCTNS/DCRB/STORE/MTO/Cyber cell/ LIU Churachandpur section (11). Projector Machine (BENQ) from Store Room.

Hence, a Suo-moto case under FIR NO. 90(2)2024 GCP-PS u/s 143/147/148/149/188/427/435/436/34 IPC, 3/4 of PDPP Act has been registered against the unruly mob for

investigation.
