## SUB: LODGING FIRST INFORMATION REPORT

It is to inform that on dated 15th Feb 2024 at about 1945 hrs a crowd gathered in front of mini secretariat (DC office) adjacent to Peace Ground. The crowd started heavy stone pelting on own Morchas and living accommodation, cook house and tried to torch civil bus No. AS 24C 2869 allotted to 'G' coy 183 Bn BSF. The driver seat of the bus was set on fire by the unruly crowd which was extinguished by own troops. Windshields and window glasses of the bus have been broken by stone pelting. A Truck bearing No MN 04 A 8119 alloted to TAC HQ M&C- XI windshields has been also broken by stone pelting. To dispress the crowd our troops fired 14 Nos PAG (Pump action Gun Non lethal weapon) round and 02 Stun grenade. Details as follows:-

 No. 01000136 HC Abdul Majeed fired 04 PAG rds (Lot No. 33 MHA 18-04-15) from PAG Butt No .01 Body 00041, No. 114770413 Ct Palash Das fired 10 PAG rds (Lot No. 33 MHA 18-04-15) from PAG Butt No .02 Body No 00042. Total - 14 PAG rds were fired. All 14 Nos PAG EFC have been recovered. No 01130273 HC Vikram Singh fired 02 Stun grenade (Lot No-

32).
