





SUB: - LODGING OF FIR REGARDING DAMAGE OF BSF/CIVIL VEHICLE/ INJURY Churachandpur Police Station
Manipur

Firing, stone pelting and burning incident at CCPUR/ CI post peace Ground and DC residence CC pur. On 15 Feb 2024 at about 1930 hrs appx 150 civil public gathered in front of DC office CC Pur, they were protesting against the suspension of one Havaldar of kuki community who was put under suspension by SP CC pur for making video grapy with miscreants and to make viral it on social media. Troops of ITBP comma E/171BN of CRPF, 105 BN RAF and local police deployed there, Tried to stop the crowd at the DC office CC pur. After some time gathered crowd started ringing the poles and suddenly appx 1500 more crowd gathered, Came close to DC office gate no 01 and brock the gate. Security forces deployed in DC office fired tear smoke shels to disperse the crowd. By this firing the crowd moved towards CI post peace ground. Crowd suddenly started stone pelting towards CI post peace ground and attempted to set on fire, civil bus registration no AS 24 C 2869 and civil truck registration no M N 04 A 8119 which were allotted for G coy of EX 183 BN BSF which is also deployed at CI post peace ground under Adhoc M & C XI by civil administration, those vehicle were parked out side CI post peace ground campus. Troops of C Coy of 10 BN BSF and G Coy EX 183 BN BSF challenged the miscreants to not set on fire the civil vehicles which were parked outside of ci post peace ground but unruly Mob did not pay heed and set on fire the civil bus and started heavy stone pelting and also used gulel, petrol bottles etc towards CI post peace ground. To save the man and materials troops of C coy 10 BN BSF and G Coy of EX 183 BN BSF fired non lethal munition to disperse the Mob. Subsequently extinguished fire of civil buses by spring water with bucket. Due to firing of non lethal munition by BSF troops unruly Mob run towards DC office and at about 152230 hrs.

Due to stone pelting by mob, one stone hit on right side of upper lip of no 012213759 Insp Chitrakesh, offg coy comdr, one stone hit on right hand palm of no 020034272 Ct Santosh Kumar Singh and one stone hit on right leg of no 873621539 Asi Naresh Pal Singh. the Injuries are not of serious nature.

Also damages occurred to following vehicles which were parked inside of ci post peace ground campus, due to stone pelting the unruly Mob.

01. BSF Tata 5 ton comma registration no MN 02 9984 wind screen broken.
02. BSF Bunker Gypsy registration no AP 23F 6104 right side rear view mirror broken.
03. Civil vehicle registration no MN 07 D 1129 Tata winger left and front side glass broken.

Troops of C coy 10 BN BSF fired non lethal munition at about 152100 hrs and up to 152230 hrs situation came under control. Details of fired munition are as under.

1. Tear smoke stun shell 13 nos.
2. Tear smoke hand grenade 04 nos.
3. Dye marker hand grenade 04 nos.

BSF troops protected the CI post peace ground and also civil bus and truck attached with G coy EX 183 BN BSF under Adhoc M & C XI.

It is requested that necessary action may please be taken against unknown miscreant who had done stone pelting on BSF Camp and damaged BSF and Civil vehicles. Case may be registered. The copy of same may be provided to BSF for further action.
