


Subject: Report on crimes of unlawful displacement, looting, property destroyed and discrimination of scheduled tribes.

With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the *Vaiphei Tribe*, which is a recognized tribe under the Constitution of India and a permanent resident of House No. <sup>54</sup>, Kangvai Village, Kangvai, P.O., P.S. & district- Churachandpur, Manipur.

That, due to the ethnic crisis in the State of Manipur, we deserted our above mentioned house on the 3<sup>rd</sup> of May, 2023 at around 3:30 PM, to save ourselves from the Meetei/ Meitei warmongers and during our absence, an armed Meetei/ Meitei suspected to be members of Arambai Tengool including the Valley Based Insurgent Groups shot my house with their sophisticated weapons, that resulted in destroying the roof of the said house with 11(eleven) bullet holes, on the 27<sup>th</sup> of July, 2023 at around 6:30 AM, therefore, I would also like to add that on the same day( 27<sup>th</sup> of July, 2023) at around 9:30 PM, 4(Four) Pigs that I was rearing for livestock was stolen by unknown miscreants.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about **Rs.40,000/- (Rupees Forty Thousand)** Only, inclusive of the destroyed roof along with the 4(Four)Pigs.

That, I am filing this report lately as I was with family at relative's village located at a remote area for months, taking refuge until we moved to EFCI Hmar Veng Relief Camp, P.O., P.S. & District- Churachandpur, Manipur.

Therefore, I humbly pray you to kindly register an FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application on behalf of my husband lately today.
