Subject: Report on crimes of unlawful displacement, property destroyed and discrimination of Scheduled Tribes.

With references to the above cited subject, I have the honour to report to you as follows:

I am a scheduled tribe belonging to the *Any Kuki Tribe*, which is a recognized tribe under the Constitution of India and a permanent resident of G.Mongjang Village, P.O., P.S. & district- Churachandpur, Manipur.

That, due to the ethnic crisis in the State of Manipur, we deserted our above mentioned house on the 3rd of May, 2023 at around 3:30 PM, to save ourselves from the Meetei/Meitei warmongers and during our absence, a mob of Meetei/ Meitei suspected to be members of Arambai Tengool, Meitei Leepun, Valley Based Insurgent Groups (VIBs) and the local in and around the area attacked our village with sophisticated weapons from an unknown location (Meitei/Meetei' area), leaving behind bullet holes on the roof, which was fired from their sophisticated weapons, causing damages to the household properties, on the 4th of May, 2023 at around 6:20 PM.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about **Rs.60,000/- (Rupees Sixty Thousand)** Only, inclusive of the roof and the household items/properties.

That, I am filing this report lately as I was with my family at remote areas for months working as a cultivator.

Therefore, I humbly pray you to kindly register an FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
