Subject: - Report.

Sir,

I have the honour to state that today i.e. 11/10/2024 at about 07:30 am, a reliable information was received from our own sources about the presence of some active cadres of KCP organisation in and around MG Avenue area of Thangal Bazar with a view to commit prejudicial activities like extortion of money from the general public, shops etc. Acting on the information, teams of CDO-IW led by Subedar Ch. Surjit Kumar of CDO-IW and myself under the command of Shri M. Amit Singh, MPS, Addl.SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at MG Avenue area of Thangal Bazar. During the search, one unknown person was found standing near Emoinu Dawat Restaurant, MG Avenue in a very suspicious manner. Due to his suspicious nature, he was detained at the spot for verification and checking. During spot verification he identified himself as Leiphrakpam Jeneyson Singh (42 yrs) @ Punil S/o. (L) L. Indrakumar Singh of Nagamapal Kangjabi Leirak, Imphal West District. On spot body search, the following articles were recovered from his possession: 1) one Redmi 13C 5G mobile handset along with two Airtel SIM cards i.e. (a) one Airtel SIM card bearing No. 0124 ID 8991160990024209961U (Phone No. 6909632820 as disclosed by him) and (b) one Airtel SIM card bearing No. 8991160990009412403U and 2) a sum of Rs. 1000/- (Rupees one thousand only).

During preliminary verification he disclosed that he is an active member of KCP (Lamyamba Khuman) organisation and he started working for the said organisation since December 2021 and he is presently working under the command of one s/s Commander namely Naoba (Finance) (Ph. No. 8732876668 as disclosed by the detainee) from Thoubal Athokpam of KCP (Lamyamba Khuman) organisation and under the instruction of his commander he served monetary demand to various shops located in and around Imphal area and he handed over the extorted money to his commander for their party fund.

Hence, he was arrested from the spot at 08:46 am and the above recovered articles were seized from the spot at 08:48 am by observing formalities.

Hence, the arrested person along with the seized articles is handed over to you for taking further necessary legal action against him.
