Sir,

I the undersigned have the honour to report that on 16/11/2024 at about 2:50 pm several groups of people mainly youths came in Khwairamband Bazar area and protest jointly with the womenfolk of Ema Keithel against the brutal killing of three women and three children at Jiribam. The nature of protest became more violent and tried to proceed towards the Chief Minister's Bungalow as well as the residences of Ministers and MLAs with a manner to destruct their residences and property. I along with two other representatives of Ema Keithel namely Kshetrimayum Shanti Devi aged about 62 Years W/O Thoudam Dilip of Keishampat Dhobi Machu Leirak and Thingujam Rani Devi aged about 62 years W/O (L) Th. Raghumani Singh of Thongju Pheija Leitong requested to the protesters to protest democratically. Then, some women and youths who were present in the protest started assaulting us in front of public on the ground that we were reluctant to obey their wild protest. As a result, we got seriously injured and finally rescued by the police personnel safely. Such acts of them amounts to assault and outraging modesty of women which is a serious crime.

I, therefore requested your good office to take necessary legal action against them as per law.
