With reference to the above subject a consignment was consisting of 750 cartons in different packing of 1 ltr bottle & 500ml bottle of Engine brand mustard oil from Guwahati vide Hari Vegetable Products Pvt Ltd invoice no. 24-25/OL538. The material was transshipment at Guwahati (Azara station) and was loaded into truck number AS21AC0813 on 21.11.2024 through transporter New Randhawa Goods Carrier (Prop. Kashmir Singh).

At the time of opening the truck tirpal for unloading at our godown at MG Avenue on 27.11.2024, Thangal Bazar, Imphal we found that some quantity of cartons were missing from the truck and therefore alerted City police, Imphal. After unloading entire material from truck, we found that 205 cartons of 1ltr bottle were missing from truck.

Hence, you are requested to investigate the matter and register an FIR for theft of mustard oil cartons.
