Sir,

With due respect, I have the honour to report that today i.e. 17/11/2024 @ 5:15 pm, while conducting random frisking and checking by joint operation team of Special Operation Team, Mao-PS along with Mao COB of 16 Assam Rifles, at Martyr's Park, Mao about 2 kms south of Mao PS, one Tata Yodha bearing Regd. No. AS21AC-2668 was seen coming from Senapati towards Mao. The said vehicle was stopped by the joint team for frisking and checking. While checking, 50 soap cases of suspected heroin powder was found concealed under the front doors (left and right) of the vehicle. The driver identified himself as Ansarul Islam 22 yrs (DOB: 12/02/2002) S/o Kuddus Ali of Paraliguri Village, Marigaon District, Assam. Ansarul Islam admitted to have possessed suspected heroin powder inside the vehicle. ADM/MAO was intimated and a request was made for authorizing the detailed inspection of vehicle. Accordingly ADM/MAO Shri. Ningreingam Leisan (45) yrs. (Executive Magistrate), Song Song himself arrived for doing the necessary procedures. The vehicle was checked in the presence of Shri. Ningreingam Leisan, ADM/Mao, police personnel and troops of Mao COB 16 Assam Rifles.

The 50 (fifty) transparent plastic packet (without the weight of 50 (fifty) plastic soap cases) were weighed by using weighing machine with video coverage as per BNSS in presence of the Executive Magistrate and witnesses and it was found to be 0.578 grams. (Including the weight of polythene and 50 plastic cover) Along with two mobile phones (1) Nokia bearing IMEI No. 352521700363228 with Airtel SIM Card bearing No. 9233748172 (2) Redmi 12 5G bearing IMEI No. 861888074853561, 861888074853579 with Two SIM Cards bearing mobile No. 9365935750 (Jio), 7636887273 (Airtel) and Aadhaar card namely Ansarul Islam 22 yrs S/o Kuddus Ali of Paraliguri Village, P.O. – Silpukhri, Marigaon District, Assam A/P Naharbari, Master Colony, 1-Mile, Dimapur bearing No. 527008539000. Hence, the above mentioned articles were seized by preparing a seizure memo at 5.45 pm and formally arrested him at 6.00 pm by completing formalities at the spot.

Therefore, the seized items along with the arrested accused person are handed over to you for taking further necessary legal action please.
