Sir,

I have the honour to state that today i.e., 05/10/2024 at around 12.30 am 5 (five) unknown armed miscreants suspected to be Kuki militants had forcibly entered at the work site of M/S Vicent Nameirakpam located Makhabasti near Sani Mandir along JT road, Jiribam and threaten to drop them towards Chhotobera side along JT road in our DI vehicle bearing No. AS 11DC-9301. Later on, I along with Bishnu Barman (33) yrs S/O. Sudhir Chandra Barman of Kalamati, Cooch Bihar, West Bengal who is working under M/S Vicent Nameirakpam as an operator of HDD Machine was abducted by the unknown armed miscreants and also threaten me to drive the vehicle immediately from there. After driving a distance of about 5 Kms. the vehicle was stopped by the unknown armed miscreants and Bishnu Barman (33) yrs S/O. Sudhir Chandra Barman of Kalamati, Cooch Bihar, West Bengal was detained there. Then I along with my vehicle was released from there demanding a sum of Rs.15, 00, 000/- (fifteen lakhs) as ransom. In the meantime, I came to know that one unknown caller from mobile no.7896785168 also threaten the younger brother of Bishnu Barman (33) yrs S/O. Sudhir Chandra Barman of Kalamati, Cooch Bihar, West Bengal to his mobile number 9954780695 to hand over the said amount with dire consequence.

It is, therefore, requested to kindly take up necessary action against the unknown armed miscreants suspected to be Kuki militants and rescue the said kidnapped person at the earliest.
