On the way at near Chotobekra Police post some womenfolk of Kuki Hmar community stopped the passenger vehicle and informed us not to go to Borobekra as we are Meitei Pangal as well as State Police. So, we 4(four) returned back in the said vehicle and dropped at Latingkhal. After reaching Latingkhal we hired one Auto Rickshaw and coming towards Jiribam. On the same day at around 4:00 pm while we are reaching Seijang Village near tea-estate, some unknown persons suspected to be Kuki militants armed with sophisticated weapons numbering about 7/8 stopped the Auto Rickshaw. Then, the unknown persons forcibly taken down from the Auto and moved towards the jungle and collected our mobile phones and body searched one by one. They had threatened us with dire consequence not to bring any kind of goods for Meitei community. After some time, they have given our mobile phones and released. Then, we again boarded in the Auto and reached Jiribam.

It is, therefore, requested kindly to take up necessary legal action against the unknown persons accordingly. I could not report the matter in time due to engaging in law and order duties in our jurisdiction of Borobekra Police Station.
