



Immediately, I ran out of the room and found that our post commander namely Sub-Inspector Md. Shah Jahan was shot dead by one C/No. 1915034 A. Bikram Singh of Mongbung village Police Picket, Jiribam by using his service .303 rifle and Sub-Inspector Md. Shah Jahan was found in a chair with bleeding injury on his chest inside our police picket.
