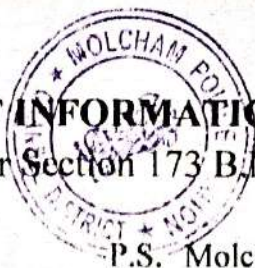

Sir,

With due respect I have the honour to submit a report that based on technical inputs regarding move of contraband/Narcotics on Khangbarol-Joupi-Chakpikarong road a party was launched under Assistant Commandant Rajveer at 1915hrs on 18 Jan 2025. A Dynamic MVCP was placed at Village Mombi (Notified Area) RM 410135 at around 1945hrs, the party intercepted a Maruti Gypsy without number plate (Regn No AS-11-A-3508 as per RC) along with two individuals. Upon details search of the vehicle, sixteen Soap Cases of Brown Sugar were recovered apart from one Myanmarrese Liquor bottle and two pouches. Veh was moving from Khagbarol (Chandel) to Churachandpur.
