- 1. Based on specific input from own sources and Early Warning detachment in Moltuk Coy, two search parties were launched from Temporary Operating Base Yangoubung on 29 Dec 2024 at 1500 hrs with str 01-00-08 in Gen A GR-736070 Thingphai vill and Str 00-01-08 in Gen A GR-749083 T S Laijang Vill. Both the parties started searching the road axis and adjoining tracks from Thingphai and TS Laijang vill. During the search Ops deliberate search of the forest area was carried out using a metal detector and drone which led to the discovery of a concealed hideout. The following war like stores was recovered.
