Today i.e. 01/01/2025 at 7:20 pm received an information that on the same day at around 7:10 pm one Maruti Suzuki, Celerio VXi, Red in Colour bearing regd.no.MN01AK2845, proceeding from Sawombung side towards Imphal side along NH-202(Imphal-Ukhrul Road) collided with one TVS Jupiter Scooter, Grey in colour bearing red. No. MN06SK K2513 coming from opposite direction at Chingarel Tejpur near YLK playground due to rash and negligent driving/riding on the part of the driver/rider of both the vehicles. As a result of which the scooterist and the pillion rider of TVS Jupiter got injuries on their persons and evacuated to hospital for medical treatment. Both the vehicles were also damaged.
