

Today i.e. 17/01/2025 at 8:25 p.m., received an information that on the same day at about 8:00 pm, one individual identified as Arish Khan aged about 26 yrs S/o Ajijur Rahman of Kiyamgei Muslim Awang Leikai was found lying near Kiyamgei Muslim Awang Leikai near Kabristan in an unconscious state who was assaulted by unknown miscreants and his hand and feet were tied with rope and his mouth was wrapped with transparent cello tape and evacuated to Hospital by nearby local people for medical treatment.


