12. First Information Contents.

Complainant namely Laishram Ongbi Surnaiata Leima lodged a written report to OC/APS stating today i.e. the 02nd November, 2024 at about 01:30 p.m. that the brief facts of the case is that I purchased the agricultural land measuring .74 acre covered by Patta No. 333(Old), 411(New) under Dag No. 3580 of Village No. 104 Top Chingtha, Imphal East District, Manipur from Maisnam Nongol Laishram Ongbi Keinatombi Devi aged about 39 years w/o L. Romeo Singh of Yairipok Bishunaha Chabungbam Leikai P O & P S. Yairipok, Thoubal District Manipur at present Poiroukhongjin P.S. Andro Imphal East District, Manipur C/O Maisnam Magha Singh. As such she filed original suit No. 22 of 2015(80/2018) in the court of the Civil Judge Senior Division Imphal East, Manipur against the said Keinatombi Devi for (a) a decree for directing Keinatombi Devi to execute register Sale Deed in respect of the said land in favour of me, (b) a decree for permanent injunction restraining Keinatombi Devi and her men from entering into the said land, (c) a decree for injunction restraining the said Keinatombi Devi to sell the said land. After long litigation the Hon'ble court of Civil Judge Senior Division, Imphal East, Manipur passed his Judgment and order dated 07.04.2018 and prepared its decree dated 07.04.2018 directing the said Keinatombi Devi to execute registered sale deed in respect of the suit land in my favour.

2. That the said Keinatombi Devi filed an appeal before the High court of Manipur being RFA No. 7 of 2018. The said appeal was dismissed on 10.5. 2018.

3. That the said Keinatombi Devi failed to execute registered sale deed as per the Judgment and decree dated 07.04.2018 passed in O.s No. 22 of 2018(80/2015) of the Civil Judge Senior Division Imphal East Manipur, she filed an Execution case No. 14 of 2018 for execution of the Judgment and decree dated 07.04.2018 passed in original Suit No. 22 of 2018(80/2015) before the court of the Civil Judge Senior Division Imphal East, Manipur. The Hon'ble Civil Judge Senior Division, Imphal East, Manipur executed the Judgment and Decree dated 07.04.2018 and as such my name has been recorded in the records of right in respect of the said agricultural land. As such the possession of the said land was delivered by the Bailiff of the District Judge, Imphal East, Manipur to me. As such she possessed the said agricultural land.
4. That the said Keinatombi Devi and her men disturbed she possession of the agricultural land, she filed an application being Judicial Misc. Case No. 29 of 2019 (Ref Civil Execution No. 14 of 2018) for civil Imprisonment for disobeying the court order. The Bailiff of the District Judge Imphal East Manipur arrested the said Keinatombi Devi and produced her before the court of the Civil Judge, Imphal East Manipur on 14/10/2019 on the said day the said Keinatombi Devi submitted an undertaking before the court that she will obey the order of the court in future and she will never interfere to my possession over the suit land. As such the Hon'ble court of the Civil Judge Senior Division passed an order dated 14/01/2019.
5. That it may be mentioned that the said Keinatombi Devi and her father Magha Singh in collusion with each other filed a civil Suit being original suit No. 50 of 2018 before the court of the Civil Judge Senior Division Imphal East, Manipur for a decree for declaring that (a) the plaintiff (Magha Singh) is the owner in possession of the suit land, (b) a decree for permanent/perpetual injunction restraining me and Keinatombi Devi and their men and agent from entering into the suit land (c) a decree declaring that the decree dated 07/04/2018 passed in original suit No. 22 of 2015/80/2015 passed by the civil Judge Senior Division Imphal East Manipur is null and void. After hearing the parties the Hon'ble court of Civil Judge Senior Division Imphal East Manipur dismissed the suit with a direction that the plaintiff Maisnam Magha Singh and his men and agents are permanently enjoined from entering into the said land.
6. That the said Maisnam Magha Singh filed an appeal against the said order and judgement and decree dated 24/7/2019 passed in original suit No. 50 of 2018 with an application dated 26/10/2020 for condoning the delay in filing the appeal being Judicial Misc. case No. 25 of 2020 before the court of the District Judge Imphal East Manipur. But the same was dismissed.
7. That it may be mentioned that during the pendency of the said Judicial Misc. Case No. 25 of 2020 in the court of the District Judge Imphal East Manipur, the said Magha Singh as plaintiff filed a civil Suit being Original Suit No. 30 of 2021 before the court of the Civil Judge Senior Division Imphal East Manipur with the following reliefs:
 - i. That recording of the suit land in the name of the defendant No. 1 (Keinatombi Devi) in the relevant land record (Document No. 3) is null and void.
 - ii. That order dated 7.3 2005 of the SDC Tulihal Imphal East Manipur in his Mutation Case No. 155/SDC/T OF 2005 and records of which are non-available, is null and void.
 - iii. That the recording of the suit land in the name of the respondents No. 1 and 2 Keinatombi Devi and Surnalata Leima respectively in the relevant land records is null and void and other reliefs.
8. The said Magha Singh also filed Judicial Misc. Case No. 181 of 2021 along with the original suit No. 30 of 2021 for passing interim injunction order for restraining her and her men. The said

case was dismissed on 30.3.2023 for concealment of the fact and directed the said Magha Singh to impose Rs .10,000/-(ten thousand) to the Manipur State Legal Services Authority.

9. That as per the order of the court, I have been possessing the said land. Thereafter the said land was transferred to one Bishoya Loitongbam but I have been possessing the same as Power Attorney Holder.

10. That in spite of knowing the said orders of the court the said persons namely (1) Maisnam Magha Singh aged about 59 years s/o /ate M. Tomba Singh of Poiraukhongjin P.S. Andro Imphal East District, Manipur. (2) Maisnam Ongbi Mitlubi Devi aged about 57 years w/o M. Magha Singh of Poiroukhongjin B P.O Poiroukhongjin, P.S. Andra, Imphal East District, Manipur. (3) Maisnam Chandrabi Singh aged about 42 years s/o M. Magha Singh of Poiroukhongjin B.P O Poiroukhongjin, P.S. Andro, Imphal East District, Manipur, (4) Maisnam Nongol Laishram Ongbi Keinatombi Devi aged about 39 years w/o L.Romeo Singh of Yairipok Bishunaha Chabungbam Leikai P.O & P.S. Yairipok, Thoubal District Manipur at present Poiroukhongjin P.S. Andra Imphal East District, Manipur C/O Maisnam Magha Singh, (5) Laishram Romeo Singh aged about 42 years s/o L. Lngocha Singh of Yairipok Bishunaha Chabungbam Leikai P.O & P.S. Yairipok, Thoubal District Manipur at present Poiroukhongjin P.S. Andra Imphal East District Manipur C/O Maisnam Magha Singh and their men always disturbed my possession of the said land.

11. That as per the orders of the court this year also she have been possessing the said agricultural land by growing Thoibi type of paddy and now the same is ready to harvest.

12. That on 02/11/2024 at about 8. A.M the above named persons along with unknown persons about forty persons entered into the said she agricultural land and harvest the paddy crops and took the harvested paddy without my knowledge and consent. Hence she file this application for taking necessary legal action against the said persons and to seize/recover the stolen paddy.

13. That on 26th Oct 2024 she filed an application to you for giving security to protect the ripen paddy. But the same is harvested by the above named persons and took the harvested paddy on 2nd Nov 2024. she, therefore, request that your good self may kindly look into the matter and take necessary legal action against the said persons and punish them according to law. Hence, the case.
