

In the last week of September, 2024, I contact him to his mobile No. 7085602836 for reaying the mortgaged amount and take back the vehicle but he said that he was busy and to fixed another date for taking back the mortgaged vehicle. After few days I tried to contact him many times but he is not picking my phone and I also went to his residence but I could not met him. It is learnt that he has sold the vehicle to another third person without my knowledge and also without the knowledge of the owner of the vehicle. The accused person has make a fake RC book and sold the vehicle to another person.


