12. First Information Contents.

Complainant namely SI. Sh. Nikhil Singh of Commando Imphal East Unit lodged a written report to OC/APS stating that on 19th December, 2024 at about 10:00 a.m. received a reliable information from 5/9 GR corroborated with their own intelligence regarding the concealment of a large number of arms, ammunitions and explosives by unknown arms miscreants in general area of Nungbram Village and Lairok Vaiphei Villlage of Imphal East District. Based on the said information, a combined team of CDO, Imphal East District and a column of 5/9 GR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops) Imphal East District conducted a searched operation in the general area of Nungbram Village and Lairok Vaiphei of Imphal East District at about 11:30 a.m. During the search operation, there found three nos. of white colour sack bags lying abandoned at the foothill of Lairok Vaiphei Village, Imphal East. On opening the sack bags there found the undernoted arms, ammunitions and explosives; (1) One 7.62mm Russian RPD machine gun bearing regd. no. '714754,' (2) One 5.56 mm INSAS rifle bearing regd. no. '18282839' along with two magazines, (3) One 0.32 Pistol bearing regd. no. 'Z-4036' with magazine, (4) One 2" Mortar bearing regd. no. 'L-5109', (5) One 12 Bore Single Barrel Gun bearing regd. no. 'T-1039', (6) One explosive with Ctn. weighing about 2.5 Kilogram, (7) 2 (two) nos. of Pompi Gun, (8) 1 (one) Pompi Cell, (9) 2 (two) nos. of No. 36 Hand Grenade, (10) 2 (two) nos. of WP Hand Grenade, (11) 2 (two) nos. of Wireless Radio Set, (12) 2 (two) nos. of Tube Launching, (13) 1 (one) 60mm Improvised Motar Shell, (14) 2 (two) nos. of 82 mm Heavy Shell, (15) 1 (one) 60 mm Improvised Motor High Calibre launcher, (16) 60 (sixty) nos. of 7.62mm live ammunitions, (17) 40 (forty) nos. of 5.56mm live ammunitions, (18) 3 (three) nos. of .32 mm ammunitions and (19) 2 (two) nos. of 12 Bore cartridges. Accordingly, the said



abandoned arms, ammunitions and explosvies were seized at 1:20 p.m. from the foothill of Lairok Vaiphei Village by observing due formalities. Hence, the case.

I have the honour to report that today i.e. the 19th December, 2024 at about 10:00 a.m. received a reliable information from 5/9 GR corroborated with our own intelligence regarding the concealment of a large number of arms, ammunitions and explosives by unknown arms miscreants in general area of Nungbram Village and Lairok Vaiphei Village of Imphal East District.
