## 2. First Information contents:

On 17/08/2024 at about 7.15 p.m., while a combined team consisting of self, personnel of 8 Bihar Regiment and B-33 Bn BSF were on duty at the Check Post (Naka) in front of the gate of Lamlai P.S., intercepted 4 light vehicles i.e., 2 Maruti Gypsy, 1 Ciaz car and 1 KIA car coming from Napet Palli towards Lamlai side. The said vehicles along with the occupants are detained thereat for checking and verification of the vehicles and the occupants. The occupants are numbering about 13 UNLF(P) members. Some of them are in camouflage dress holding sophisticated fire arms and some other are in civies. In the meantime a police team of Imphal East District headed by the Addl. SP Ops, the SDPO-Lamlai, the OC, CDO-IE arrived at the Lamlai Police Station gate and supervised the process of checking and verification of the vehicles and the occupants. The UNLF(P) armed miscreants are asked to disarm before conducting checking and verification but refused to disarm. While pursuing to disarm, suddenly a huge mob of women numbering about 1000 stormed the check gate of the PS. Unfortunately, the members of the unruly mob covered the PS campus besides covering the main road where the check gate is. The unruly mob have given stiff resistance to carry out the checking and verification of the vehicles and the occupants detained. They asked to release them then and there. The security forces, on duty there, made an attempt to disperse the said mob and attention have been focussed to disperse the mob that prevents the lawful discharge of duty. While trying to disperse the unruly mob, the security forces faced a very tough time. Taking advantage of the turmoil and darkness the UNLF(P) members made their good escape. The mob has facilitated the escape of the UNLF(P) members.

Hence, a suo-mottu case under FIR NO. 22(8)2024, LLI-PS U/S 189(2)/191/221/223 BNS & 25(1-B) Arms Act has been taken up for investigation.
