Complainant namely Sl. Sh. Nikhil Singh of Commando Imphal East Unit lodged a written report to OC/APS stating that on 23rd December, 2024 at about 9:00 a.m. received a reliable information from 5/9 GR corroborated with his own intelligence regarding the concealment of a Nos. of arms, ammunitions and explosives by unknown arms miscreants in general area of Ngariyan Hill ranges of Imphal East District. Based on the said information, a combined team of CDO, Imphal East District and a column of 5/9 GR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops) Imphal East District conducted a searched operation in the general area of Ngariyan Hill range along Sandangsemba Maring Village, of Imphal East District at about 9:30 a.m. During the search operation, there found two nos. of sack bags, one white in colour and the other yellow in colour, lying abandoned at Ngariyan Hill near Don Bosco School, Imphal-East. On opening the sack bags there found the arms, ammunitions and explosives i.e. (1) 1 (one) no. of 303 inch Bren MK-II LMG, bearing regd. no. 'S-5447' with magazine (2) 1 (one) no. of 12 Bore Single Barrel Gun bearing regd. no. 'A-1011' (3) 1 (one) no. of 9 mm Pistol bearing regd. no. 'B-2396' with magazine (4) 2 (two) nos. of Hand Grenade with two arm ring (5) 2 (two) nos. of Tube Launching (6) 30 (thirty)nos. of 303 LMG ammunitions (7) 2 (two) nos. of 12 Bore cartridges (8) 2 (two) nos. of 9 mm ammunitions and (9) 2 (two) nos. of sack bags, one white in

colour and the other yellow in colour. Accordingly, the said abandoned arms, ammunitions and explosives were seized at 10:55 a.m. from Ngariyan Hill, about 400 meters away from the back side of Don Bosco School, Ngariyan, Imphal East by observing due formalities. Hence, the case.

Sir,

I have the honour to report that today i.e. the 23rd December, 2024 at about 9:00 a.m. received a reliable information from 5/9 GR corroborated with our own intelligence regarding the concealment of a nos. of arms, ammunitions and explosives by unknown arms miscreants in general area of Ngariyan Hill ranges of Imphal East District. Based on the said information, a combined team of CDO, Imphal East District and a column of 5/9 GR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops) Imphal East District conducted a searched operation in the general area of Ngariyan Hill range along Sandangsemba Maring Village, of Imphal East District at about 9:30 a.m.

During the search operation, there found two nos. of sack bags, one white in colour and the other yellow in colour, lying abandoned at Ngariyan Hill near Don Bosco School, Imphal-East. On opening the sack bags there found the undernoted arms, ammunitions and explosives;

- (i) 1 (one) no. of .303 inch Bren MK-II LMG, bearing regd. no. 'S-5447' with magazine,
- (ii) 1 (one) no. of 12 Bore Single Barrel Gun bearing regd. no. 'A-1011',
- (iii) 1 (one) no. of 9 mm Pistol bearing regd. no. 'B-2396' with magazine,
- (iv) 2 (two) nos. of Hand Grenade with two arm ring,
- (v) 2 (two) nos. of Tube Launching,
- (vi) 30 (thirty)nos. of .303 inch LMG ammunitions,
- (vii) 2 (two) nos. of 12 Bore cartridges.
- (viii) 2 (two) nos. of 9 mm ammunitions and
- (ix) 2 (two) nos. of sack bags, one white in colour and the other yellow in colour.

Accordingly, the said abandoned arms, ammunitions and explosives were seized at 10:55 a.m. from Ngariyan Hill, about 400 meters away from the back side of Don Bosco School, Ngariyan, Imphal East by observing due formalities.

Therefore, the seized items are being handed over to you for taking up further necessary legal procedures.
