Subject: Complaint Report

Sir,

I have the honour to report that today i.e. the 20th August, 2024 at about 11:30 am while I was in my house, two unknown persons who came in a car, approached me and inquired about my particular to which I identified my particular to them. After that they asked me to accompany them as they had received a complaint against me from one person not known to me. I enquired the identities of the two unknown persons to which they told me that they were members of KCP. When I showed reluctance, the two persons threatened me and I was compelled to follow them. Out of fear, I followed them and found three women inside the car cream in colour with its registration number ending with 32. Then I was forcibly seated in the car by the two miscreants along with the other women. I heard the two male miscreants thanking the other women in the car for helping them in identifying my house. Then, they drove the car towards south and out of fear I remained silent. When we had reached Chingkhei Ching, one man and a woman not known to me who were seen to be waiting for me to come, approached me and looked at me as if they were identifying me. Then, they had some discussion and after that asked me to climb down from the car to which I complied. After that, they together immediately fled away leaving me at the spot Chingkhei Ching. After that I contacted my family members and they took me back home safe. For no reason, I was kidnapped and threatened by the said unknown persons for reason not known to me. These has created a sense of insecurity and frightened me thus caused mental trauma. I therefore request you to kindly enquire into the incident and punish the culprit as per law of the land. I'll be grateful to you.
