Thave the honour to report that today i.e. the 28th August, 2024 at about 10:30 am received a specific information from own source about the presence of some active armed cadres of the outlawed organisation KCP (Noyon) numbering about 10 to 15 cadres led by one Huidrom Sunder Singh (35) yrs S/o H. Shamu Singh of Sekta Awang Leikai, Imphal, Imphal East District along with sophisticated arms and ammunitions which had been looted from various Police/Armed Battalion arm-Kotes and taking shelter in a house at Sekta Awang Leikai, Imphal East District.

After informing senior Officers, a joint team of Imphal East District Police comprising of Addl. SP (L&O)IE, Addl. SP (Ops)IE, OC-CDO/IE, OC-LLI/PS and other CDO teams and women Police personnel of Imphal East, CDO teams of Imphal West and teams from Special Commando Unit, Khabeisoi, Immediately, the combined team rushed to the said area i.e. Sekta Awang Leikai, Imphal East District and approached towards three suspected houses. In that about 4-5 persons were seen running away at a distance towards the Iril river. The Police team chased them however they crossed the river and took cover of the heavy outgrowth. Search was conducted in the area at around 11.30 am.

In that one house belonging to one Huidrom Sunder Singh (35) yrs S/o H. Shamu Singh of Sekta Awang Leikai, I/East District was searched and found inside his house three nos. of INSAS rifles with three nos. of magazine, one INSAS LMG along with one magazine, one Excalibur along with one magazine, two AK 56 Rifles with two magazines, one hundred 5.56 mm INSAS ammunitions, twenty-nine nos. of 7.62 X 39 mm A.K. rifle ammunition, one 7.62 mm SLR ammunition, 2(two) nos. of mobile phones and some combat dresses and incrementing articles. While the police teams were conducting search in the house and its surrounding areas a large mob comprising of mostly women started approaching towards the police team apparently with intention to obstruct the police from pursuing the miscreants and from conducting search. The police teams tried to persuade the mob to disperse but the mob turned violent and started directly obstructing the police teams. As a large resort, police used some anti-riots equipments and dispersed the mob from the spot and conducted further search.

Considering the situation and importance of further legal procedures which could not be conducted at the spot due to intensified mob violence, the above arms, ammunitions, mobile phones, and other incriminating articles were collected from the spot under video coverage and brought to the office of CDO-IE unit located at Porompat, Imphal East District. Immediately the mob storm the Sekta Police outpost but some police teams including CDO protected the post and stopped the mob and some police teams evacuated the arms and ammunitions and others articles that were collected from the above mentioned spot. Additional teams were reinforced and dispersed the mob at around 4:00 PM. Then, the combined team came back to the office of CDO-IE Unit.
