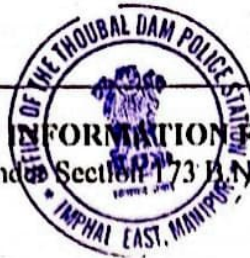

Subject: Report.

Sir,

1. I have the honour to state that today i.e. 19 Sep. 2024, at about 8.00 am received a reliable information about the presence of IEDs at the general area of Bongjang. Acting on the information, a combined search operation team with Thoubal Dam Police Station team was organized.
2. The combined team carried out search operation in the General Area of Bongjang at 9.30 am.
3. After careful searching of the general area, the following items were recovered:-
  - (a) 07 x IEDs weighing around 28.5 kgs explosive.
  - (b) 50 mtrs cordtex.
  - (c) 01 x pull & release mechanism.
4. Accordingly, the IEDs and other war like items were formally seized at 1.25 pm from the general area of Bongjang Hill terrain. The search operation was concluded at 2.15 pm of the same day and handed over the seized articles to the Thoubal Dam PS.
5. It is requested to send these IEDs to FSL Analysis Laboratory, Pangei to investigate the details of explosives used in the IEDs.
6. It is also requested to investigate about the origin of the IEDs as well as the intention behind planting IEDs at the specific location and further to take appropriate action against the unknown/unidentified miscreants involved in the planting of IEDs.
7. Therefore, it is requested to initiate necessary legal action against the unknown miscreants as per law of the land.
