

- 1. I have the honour to state that today i.e. 24 September 2024 at about 4:30 am received a reliable information from 5/9 GR corroborated with our own intelligence about the presence of some anti social elements in and around the Bongjang Hill range, Kangpokpi district. Based on the said information, a combined team of CDO I/E unit led by Subedar K Ibungobi Singh along with a column of 5/9 GR Laikhong and teams of OC Thoubal Dam Police Station Inspt. Md Shahid Khan, troops of A coy. 29 Bn BSF lead by Inspt. RP Singh, and under the overall supervision of Shri Kh. Herojit Singh, MPS, Addl SP (Ops) of Imphal East district, search operation team was organized.
- 2. Acting on the information, the combined team conducted the search operation in the general area of Bongjang Hill range about one and half kilometer up to the hill and its surrounding area at 5:30 am. And, teams also search suspected routes which can be taken by Kuki militants.
- 3. In that, the combined team found and recovered a large nos. of arms and ammunition and bomb during the search operation. The following items were recovered:
 - 1. 01 x 7.62 mm Bolt Action Sniper rifle (Regd. No P-1622) with 9 x Scope
 - 2. 01 x 50 mm Heavy calibre Launcher

 - 5. 01 x Explosive with container (2.5 Kg)
 - 6. 10 x live 7.62 mm Sniper rifle ammunition.
 - 7. 13 x Ballistic Cartridge.
 - 8. 02 x Live 12 Bore Cartridge
 - 01 x Baofeng radio Set.
