First Information contents:

On 30/10/2024 One Mr. **Aleks Vashum** of Talui Village, Ukhrul and founder of Thapo's Mistry Hills, located at Khuilungtang, Hungpung, Ukhrul District, Manipur reported to this PS that regarding the non-delivery of goods by Stalwarts Trading and Manufacturing Company. My company placed an order with Mr. **Sudhakar Chaudhary** of aforementioned company for the delivery of certain equipment. Initially, representative from their company visited my business premise in June 2022, and I subsequently visited their office in Nashik in October 2022. Following these interactions, they assured me that the goods would be delivered by October 2022, after Diwali. The total payment for the order, including delivery charges, was Rs. **9,85,720/-** which has already been made in full. However, despite repeated follow-ups, the goods have not been delivered to date.
