Suddenly, a beeping sound received by Deep Search Metal Detector (DSMD). By taking care the deep search of area started. After careful searching we found the following items / articles:

  - (b).01 x 2.5 Kg IEDs
  - (c).01 x 50 mtrs cordtex.


