Subject :- An application file for lodging of FIR in Cognizance Order by the Supreme Court 25/09/2023 H.D. Order of the Governor of Manipur dated 10/10/2023 & by the Supreme Court appointed Justice Gita Mittal Committee in connection of Property of IDPs in the State. Order of the Land Resources Deptt. dated 06/06/2024 against the protection of my Agricultural land (Phourel) at 75-Moirang purel, under Maphou Dam P.S. Kangpokpi District.

Sir,

With due respect, I the undersigned, have the honour to state the following few lines for your kind necessary immediate action.

The brief facts of the case:

That, the complainant is the land owner of Patta No.395 (old) correspondent to Patta No. 84 (New) C.S. Dag No.2218, village No. 75 Moirang purel a total area of 1.30 acres, class of land- Phourel, under Imphal east sub-division & Tehsil, Imphal East District, Manipur and also inhabitant of Maphou Kuki Village, Island block, Kangpokpi district presently displaced at Kangpokpi ward No. 17 , Kangpokpi District, Manipur.

That, the accused person/persons were Meitei miscreants (Arambai Tenggol, Meitei Leepun, UNLF, PLA etc.) causing chaos, rioting, looting properties, behaved badly and does not obey Law. They spread hate and tortured the innocent Minority communities (Kuki-Zo) in particular and among the people living in the State of Manipur in general.

That, on 4th May, 2023 my nearby Kuki-Zo villages were attacked by the said miscreants mentioned above, which led to the burning of my village on 30th May, 2023 which is under Island block, Saikul Sub-division, Kangpokpi District, Manipur and on 2nd June, 2023 all the residence run for their life in the Jungle and through divine providence, with the help of Central force we reach Litan with only the clothes we were wearing, later with the help of NGOs we reach Kangpokpi and now take shelter at Kangpokpi Ward No. 17.

That, ever since from 2nd June, 2023 onwards, I could not learn about my things that were left and I was informed by a reliable friend who is very intimate to me that the said agricultural land was not allowed for cultivation by a person whom I entrusted (Tenant) since the area was surrounded and overpowered by the Arambai Tenggol, Meitei Leepun, UNLF, PLA etc. who are the valley base terrorist organization.

The situation in the area was escalated again on 12th -13th June, 2024, when the said terrorist group overpowered and stated cultivation without the knowledge of the land owner who are in title of those land.

Given all the above circumstances, I urge your esteemed office to take swift legal action against the perpetrators to ensure justice is served. As an internally displaced person grappling with emotional trauma, I was unable to report the incident promptly.

As such, it is my appeal to your good office to look and take initiative of utmost protection to my agricultural land for further disturbance and damage for the end justice.


