12. First Information contents:

On date 16/11/2024 at 11.10 pm a group of Meira Paibis including some youths numbering about 1000 (One thousand) were came from two different direction i.e. from Lamlai side and Napet side targeting to storm the residence of Hon'ble MLA Lamlai A/C, Kh. Ibomcha Singh of Nongada. The

Police team of Lamlai PS including WPCs along with 8th Bihar Regiment stopped them and as they are so violent and using force over the Police and CAF, who were on duty Lamlai PS gate. Seek the permission to the Magistrate who is on duty and fired 12(Twelve) rounds of stunt Shell, but they forcibly proceed towards the residence of Hon'ble MLA Lamlai AC then the Police team and 33 Bn BSF "B" Coy who were deployed at MLA's residential gate stopped the crowd that crowd started pelting stone to the Police personnel and injured 2 (two) police personnel. In order to control the situation 15 (fifteen) rounds of Stunt Shell were fired and dispersed the crowd. No further unwanted incident took place. Later the two injured persons were evacuated to JNIMS Hospital for medical treatment.

Hence, a regular suo-mottu case under FIR No. 33(11)2024 LLI-PS U/S 61(1)/129/352/195/3(5) BNS has been registered for investigation.

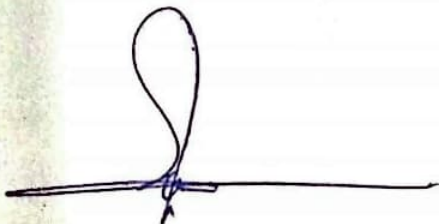

It is inform you that one of my platoon i.e. platoon of B/33 BN under adhoc M2C XXI BN is deployed at Residence of MLA Lamtai in vill - Nongda.

on 17th NOV 2024 at about 0010 HRS approx 500 unruly mob tried to enter forcefully in the residence of MLA and in order to stop them the unruly mob started Stone pelting on us. In self defence & to disperse the unruly mob we fired following non-lethal munition.

- ① Stun Grenade - 02 NOS (Lot no - 27)
- ② Chilli Grenade - 01 NO (Lot no - 01)
- ③ Tear Smoke Grenade - 01 NO (Lot no - 80)
- ④ Dry Marker Grenade - 01 NO (Lot no - 25)
